Statement of intent

Furze Platt Senior School is committed to ensuring equal opportunities for all students, regardless of financial circumstances, and has established the following policy and procedures to ensure that no child is discriminated against by our offering of school trips, activities and educational extras.

In addition, we are committed to adhering to legal requirements regarding charging for school activities, and meeting all statutory guidance provided by the DfE.

We promise:

- Not to charge for education provided during school hours.
- To inform parents on low incomes and in receipt of relevant benefits of the support available to them when asking for contributions.

1. Legal framework

- 1.1. This policy will have consideration for, and be compliant with, the following legislation and statutory guidance:
 - Education Act 1996
 - The Charges for Music Tuition (England) Regulations 2007
 - The Education (Prescribed Public Examinations) (England) Regulations 2010 Freedom of Information Act 2000
 - DfE (2018) 'Charging for school activities' DfE (2020) 'Governance handbook'
 - The trusts Funding Agreement
 - ESFA (2023) 'Academy trust handbook 2023

2. Charging for education

2.1. We will not charge parents for:

Admission applications.

Education provided during school hours (including the supply of any materials, books, instruments or other equipment).

Education provided outside school hours if it is part of the national curriculum, part of a syllabus for a prescribed public examination that the student is being prepared for by the school, or part of religious education.

Instrumental or vocal tuition, unless provided at the request of the student's parents.

Entry for a prescribed public examination, if the student has been prepared for it at the school.

- 2.2. We may charge parents for the following:
 - Materials, books, instruments or equipment, where they desire their child to own them
 - Optional extras
 - Music and vocational tuition (in certain circumstances)
 - Use of community facilities and other commercial activities.
 - Examination re-sits
 - Additional exam costs for subjects that a student is not prepared for at school.
 - Provision of information within the scope of freedom of information

3. Optional extras

3.1. We may charge parents for the following optional extras:

Education provided outside of school time that is not:

- Part of the national curriculum.
- Part of a syllabus for a prescribed public examination that the student is being prepared for at the school.
- Religious education.
- Examination entry fees where the student has not been prepared for the examinations at the school
- Transport, other than that required to take the pupil to school or to other premises where the trust board has arranged for the pupil to be provided with education.
- Board and lodging for a student on a residential visit
- Extended day services offered to students

- 3.2. When calculating the cost of optional extras, the school will only take into account the following:
 - Materials, books, instruments, or equipment provided in relation to the optional extra
 - The cost of buildings and accommodation
 - The employment of non-teaching staff
 - The cost of teaching staff (including teaching assistants) under contracts for services purely to provide an optional extra
 - The cost, or an appropriate proportion of the costs, for teaching staff employed to provide vocal tuition or tuition in playing a musical instrument, where the tuition is an optional extra.
 - The school will not charge in excess of the actual cost of providing the optional extra divided by the number of participating students. We will not charge a subsidy for any students wishing to participate but whose parents are unwilling or unable to pay the full charge. If a proportion of the activity takes place during school hours, we will not charge for the cost of alternative provision for those not participating.

Participation in any optional activity will be on the basis of parental choice and a willingness to meet the charges. Therefore, parental agreement is a pre-requisite for the provision of an optional extra

4. Examination fees and resits

- 4.1. We may charge for examination fees if:
 - The examination is on the prescribed list (which includes GCSEs, A levels, BTECs and Cambridge Technicals), but the student was not prepared for it at the school.
 - The examination is not on the prescribed list, but the school arranged for the student to take
 it.
 - A student fails, without good reason, to complete the requirements of any public examination where the governing board or LA originally paid or agreed to pay the fee.

Where a student is entered for a second or subsequent attempt at an examination, any fees involved must be covered by the student or their parents.

If a student or their parents consider it to be in the best interests of the student to request a review of marking of an examination, any fees involved must be covered by the student or their parents. If the awarding body changes the overall grade of the result, the school will not be charged by the awarding body and the parent/student will have their fees refunded.

5. Voluntary contributions

- 5.1. We may, from time-to-time, ask for voluntary contributions towards the benefit of the school or school activities. If an activity cannot be funded without voluntary contributions, we will make this clear to parents at the outset. We will also make it clear that there is no obligation for parents to make a contribution, and notify parents whether assistance is available.
- 5.2. No child will be excluded from an activity simply because their parents are unwilling or unable to pay. If a parent is unwilling or unable to pay, their child will still be given an equal opportunity to take part in the activity. If insufficient voluntary contributions are raised to fund an activity, and the school cannot fund it via another source, the activity will be cancelled, and this will be made clear to parents.
- 5.3. We will strive to ensure that parents do not feel pressurised into making voluntary contributions. Measures which may make parents feel pressured, such as colour coded letters and direct debit or standing order mandates, will not be sent when the school requests contributions.

6. Music tuition

- 6.1. Music tuition is the only exception to the rule that all education provided during school hours must be free. The Charges for Music Tuition (England) Regulations 2007 allow for charges to be made for vocal or instrumental tuition provided either individually or to groups of any size provided that the tuition is at the request of the student's parents.
- 6.2. The charges will not exceed the cost of the provision, including the cost of the staff providing the tuition.
- 6.3. Charging will not be made if the teaching is an essential part of the national curriculum.

7. Transport

- 7.1. We will not charge for:
 - Transporting registered students to or from the school premises, where the LA has a statutory obligation to provide the transport.
 - Transporting registered students to other premises where the governing board or LA has arranged for students to be educated.
 - Transporting students to meet an examination requirement when they have been prepared for the examination at the school.
 - Transport provided for an educational visit.

8. Education partly during school hours

- 8.1. If 50 percent or more of the time spent on an activity occurs during school hours (including time spent travelling if the travel occurs during school hours), it will be deemed to take place during school hours and no charge will be made.
- 8.2. Whatever the start and finish times of the school day, regulations require that the school day is divided into two sessions. School hours will not include the break in the middle of the day.
- 8.3. If less than 50 percent of the time spent on an activity occurs during school hours, it is deemed to have taken place outside school hours and we may charge for the activity; however, we will not charge if the activity is part of the national curriculum, part of a syllabus for a prescribed public examination that the student is being prepared for at the school, or part of religious education.
- 8.4. The remission of charges for board and lodging payments is the responsibility of the school. These costs will be borne by our contingency funds.
- 8.5. Any charges for extended day services will be optional.

9. Residential visits:

9.1. We will not charge for:

- Education provided on any visit that takes place during school hours.
- Education provided on any visit that takes place outside school hours if it is part of the national curriculum, part of a syllabus for a prescribed public examination that the student is being prepared for at the school, or part of religious education.
- Supply teachers to cover for teachers accompanying students on visits.
- We may charge for board and lodging but the charge will not exceed the actual cost.
- Parents will be exempt from board and lodging costs if they can prove that they are in receipt of one or more of the following benefits:
- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Support under part VI of the Immigration and Asylum Act 1999
- The guaranteed element of State Pension Credit
- Child Tax Credit, provided that they are not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190
- Working Tax Credit run-on paid for four weeks after they stop qualifying for Working Tax Credit
- Universal Credit if they apply on or after 1 April 2018, their household income must be less than £7,400 a year (after tax and not including any benefits they receive).

The school will provide a form for parents to submit and provide proof of receipt of one of the above benefit payments in order to be eligible for the exemption.

If the number of school sessions covered by the visit is equal to or greater than 50 percent of the number of half days (any period of 12 hours ending with noon or midnight on any day) spent on the visit, we will not charge for the activity.

10. Damaged or lost items

The school may charge for the cost of replacing items that are damaged or lost due to the negligence or poor behaviour of pupils or their parents. Parents will only be charged the replacement cost to purchase the same or equivalent item. The school will consider waiving costs in exceptional circumstances, e.g. financial hardship

11. Remissions

- 11.1. We have set aside a small fund to enable families in financial difficulty to send their children on visits/activities. The funding is limited and there is no guarantee that all requests can be met. Assistance will be allocated on a needs basis, and if the full cost of the trip/activity cannot be met through assistance funding and voluntary contributions, the trip/activity will be cancelled.
- 11.2. Parents in receipt of any of the following benefits may request assistance with the costs of activities:
 - Income Support
 - Income-based Jobseeker's Allowance
 - Income-related Employment and Support Allowance
 - Support under part VI of the Immigration and Asylum Act 1999
 - The guaranteed element of State Pension Credit
 - Child Tax Credit, provided that they are not also entitled to Working Tax Credit and they have an annual gross income of no more than £16,190
 - Working Tax Credit run on paid for four weeks after they stop qualifying for Working Tax Credit.
 - Universal Credit if they apply on or after 1 April 2018, their household income must be less than £7,400 a year (after tax and not including any benefits they receive)
- 11.3. To request assistance, parents should contact the School Office

12. School trip refunds

- 12.1 All initial deposits for school trips will be non-refundable. Parents will be informed of this when they are provided with initial information about the trip.
- 12.2 In the event that the school has to cancel a trip due to foreseen circumstances, parental contributions will be refunded.
- 12.3 In the event that a school trip is cancelled due to unforeseen circumstances, it is at the trip leader's discretion (in consultation with the Headteacher) as to whether a refund is given to parents. The Headteacher will take into account the cost to the school, including alternative provision cost.
- 12.4 In the event that a school trip is postponed due to unforeseen circumstances, it is at the Headteacher's discretion as to what happens with the parental contributions for the trip. The Headteacher will consider options, which could include carrying forward the money until the trip takes place, transferring the money to another trip, or refunding parents.
- 12.5 In the event that a student or their parents cancel their place on a trip, it is at the Trip leader's discretion (in consultation with the Headteacher) as to whether a refund is given to parents. The Headteacher will take into account the reason for cancellation,

- whether the school will be reimbursed for the student's place on the trip, and whether the place on the trip can be offered to another student.
- 12.6 Where a student or their parents have previously cancelled a place on a trip and received a full refund, the school has the right to refuse to allow the student to attend future trips and visits.
- 12.7 In the event that a student cannot attend a trip at the last minute (e.g., due to illness), it is at the Headteacher's discretion as to whether a refund is given to parents. The Headteacher will take into account whether the school will be reimbursed for the student's place on the trip and whether the place on the trip can be offered to another student.
- 12.8 Once trip arrangements have been booked and confirmed, if contributions exceed the total cost of the trip, a refund will be given where the excess if greater than £30 per student. If the excess is less than £30 per student, this will be paid into the school's account.
- 12.9 Excess expenditure will be subsidised by the school fund
- 12.10 The school will deal with cancellations and refunds on a case-by-case basis, ensuring that all students and their families are treated equally.

13. Income Generation

In line with the ESFA's 'Academy trust handbook', the trust will set fees for chargeable services at full cost and reserves the right to apply an additional rate of return when in a commercial environment.

14. Monitoring and review

14.1. This policy will be reviewed at least bi-annually by the Resources Committee
